Dear DC Members and MC Chairs,

In order to avoid any further misunderstanding regarding the reasons for the current tight budget situation in the COST Office, I would like to provide you with a few additional details.

As you may recall, COST had been allocated a total of 210 Mio EUR from the Commission to implement the COST Activities for the entire duration of FP7 (until June 2014). Moreover, following a successful Mid-Term Review, up to 40 Mio EUR could be additionally provided to COST by the Commission. The Mid-Term Review report did indeed recommend this additional funding, however, we are currently awaiting signals from the Commission as to when and to which amount these funds will become available. Given the current difficulties of the Commission to obtain any budget for 2011 approved by the Council and the European Parliament, it is entirely out of our (and the Commissions) hands to know when and to which amount the additional EC funding for COST might become available.

Because the CSO initially decided to approve ~30% more new actions per year than the number initially foreseen under the 210 Mio EUR scenario (30/round instead of 20/round), speculating on the 'early availability' of the additional Commission funding, we are now facing a 'temporary' funding shortage (until the additional resources are available from the Commission). While we are very optimistic to receive such additional funding, we currently ignore the date and the full amount, and therefore are obliged to maintain a more stringent budget allocation for the moment. The COST Office is fully aware that this puts severe constraints on some of the actions, but there is hope that this situation will be resolved in spring of 2011, thus limiting the impact on a short period of time. The additional funds are intended to be used to put back action budgets onto a reasonable funding level, and furthermore support the approval of a few additional actions per round.

I very much hope that this clarifies the current situation, and please feel free to address any additional questions you may have, either to Dr. Matthias Haury (Head of Science Operations at COST) or myself.
