

Attachment 3: Letters of recommendation

Please submit two letters of recommendation, assessing your ability to conduct graduate-level work and your potential for a successful academic or professional career. The letters of recommendation must be completed by faculty members, job supervisors, etc., who are most familiar with your professional and/or academic abilities and character. Referees are requested to complete these letters in English or, if written in another language, to attach an English language translation.

Attachment 4: English language proficiency certificates

A copy of the TOEFL certificate (with a minimum score of 525 (paper-based), 69 (internet-based) or 196 (computer-based)) or the IELTS-certificate (with a minimum score of 5.5) is required. Please note that the certificates must not be older than January 2014. If you cannot submit a proof of English language proficiency by the deadline, your application will still be considered. In this case you are urged to provide the proof as soon as possible, and no later than 31 May, 2016.

Applicants from English speaking countries (Antigua & Barbuda, Australia, The Bahamas, Barbados, Belize, English-speaking Canada, The Gambia, Ghana, Grenada, Guyana, Republic of Ireland, Jamaica, Kiribati, Liberia, Mauritius, Micronesia, New Zealand, Nigeria, Papua New Guinea, St. Kitts-Nevis, St. Lucia, St. Vincent, Sierra Leone, Solomon Islands, Trinidad & Tobago, United Kingdom, United States of America, Zambia or Zimbabwe) do not have to submit language certificates.

Attachment 5: Academic degree certificates in original language

A copy of all academic degree certificates, i.e. Civil Engineering degree or equivalent, master or equivalent or other graduate degrees.

Students who will not complete their Civil Engineering degree by the deadline, but who predict to graduate before 1 September 2016, can apply to this Masters course. If selected, their admission will be conditional on the receipt of the degree certificate by the MSc Secretariat before July 31, 2016 (Erasmus Mundus grant holders) and 1 September 2016 (other applicants).

Attachment 7: Copies of transcripts or other academic records

A translation of the transcripts and records made by an officially recognized translator in English, but only in case the original documents in Attachment 7 are not in English.

A copy of original documents only. No English translation is needed.
