

- **§2.** The scholar commits him/herself to use the scholarship only for the coverage of project-related travel expenditures and subsistence costs the scholar will incur during his/her visit(s) related to the SUSCOS\_M master programme; may not be used for any other programme.
- §3. The main activities of the scholar in the frame of the SUSCOS\_M master programme will be the following:
  - Teaching activities (as for instance teaching, curriculum or module development, thesis supervision, etc.);
  - Research activities related to the SUSCOS\_M master programme.
- **§4.** A detailed Plan of Activities is attached and forms part of this contract. The scholar will strictly adhere to the time frame and activities agreed upon with the programme coordinator and the hosting institution(s) and understands that any deviation from the stated plan must be approved by the Managing Board of SUSCOS\_M programme as well as the relevant consortium members.
- **§5.** In the event that the scholar discontinues the visit for personal or non-medical reasons, he agrees to repay the grant proportional to the duration of his/her visit within 2 months of the date of the discontinuation of the programme.
- **§6.** The scholar will send a Final Report to the Coordinating Institution at the latest one week after the completion of his/her visiting period and agrees to be a contact person for the prospective Erasmus Mundus scholars.
- **§7.** The scholar agrees to be fully responsible for his/her health and all other necessary insurance coverage for the time spent in the hosting institution(s) and that he/she will not hold the Consortium or the hosting institution(s) liable for any damage resulting from insufficient insurance coverage.





- §8. The scholar understands that he/she can receive a Weekly Allowance of  $1.200 \in (a \text{ week shall be counted as } 4 7 \text{ consecutive calendar days})$ , covering travel costs and life expenses including food, local transport, accommodation, etc., as scholarship grant for the 2012/2014 edition. The scholar understands that the minimum period of stay for a scholar is 2 weeks, corresponding to 2 x 1.200 (= 2.400 €), and the maximum duration is 3 months, corresponding to 12 x 1.200 (= 14.400€). In case the scholar stays for a period of 2 weeks and 3 days, the amount paid should be 2.400; in cases where the scholar stays 3 weeks and 4 days the amount paid should be 4.800. The amounts for scholar cannot be altered. There are no deviations possible from the weekly amount. The amount received includes, if applicable, any charge that was made by the bank to his/her personal account with respect to the receipt of the scholarship payment.
- **§9.** The scholar understands that the Allowance will be transferred to his/hers bank account once the Final Report has been received and duly accepted by the Coordinating Institution.
